Boost your donation by 25p of Gift Aid for every £1 you donate

Gift Aid is reclaimed by the charity from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.

I want to Gift Aid donations I make in the future or have made since 16 September 2025 to The Gateway Church (registered charity 1214969)

I am a UK taxpayer and understand that if I pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all my donations in that tax year it is my responsibility to pay any difference.

Online

Via PayPal Giving fund, who can also handle gift aid (where the government tops up with the equivalent of the tax paid at no extra cost to you).

Gift Aid

So what is Gift Aid?

Gift Aid is a scheme that lets UK taxpayers easily supercharge their charity donations. Every time you say 'yes' to Gift Aid, each tenner you give becomes £12.50 for the charity at no extra cost to you.

How do I give via Gift Aid?

Just make a donation! Sign the Gift Aid declaration on the back of this leaflet and we will do the rest. One declaration covers every donation to the Church from the 16th Sept 2025 onwards. If you donate cash please use one of the envelopes on the welcome table and put your name on it so we can claim the tax back.

I want an easy way to give regularly!

Set up a standing order or regular payment to Account name The Gateway Church Account No. 21471902 Sort Code 40-40-35 Reference: Surname giving.

Are there any limits to what I can give?

None at all!!! But remember, in each tax year you must pay as much income or capital gains tax as we are going to claim back. We can remind you of your total giving if you ask.

Does it matter if I have a joint account?

No. The gift aid declaration has a section for you to declare that it is your money you are giving – please sign it. The person who makes the declaration should sign the cheques or standing order form.

What if I pay higher rate tax?

People who pay higher rate tax can get extra relief on their donations by writing to their tax office or declaring it on their tax return.

What if I am self employed?

Start with the total amount you want to give this tax year. Divide it by 80 and then multiply it by 100. This gives you the gross (before tax) value of your giving. Will you pay income tax or capital gains tax on at least that amount of your income over the year? If so you can safely give that amount.
